WAIVER REQUIREMENTS

WHAT IS A WAIVER?

A waiver is a temporary extension that gives the vehicle owner extra time to make additional repairs before the next time the vehicle is due for emissions testing. Only one waiver, valid for one test cycle, will be issued in the lifetime of any vehicle. A vehicle is only eligible for a waiver if it meets all of the requirements listed on the chart below.

WAIVER ELIGIBILITY CHART

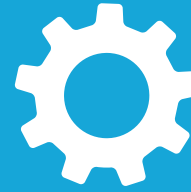
A vehicle must meet **ALL** of the applicable qualifications to be eligible for a waiver. To use this chart to determine waiver eligibility, find your vehicle's model year in the first column then read across the page to see the additional waiver requirements.

VEHICLE QUALIFICATION

If your vehicle meets all of the applicable waiver qualifications, all original receipts detailing specific parts and repairs made to your vehicle must be presented to station management to apply for a waiver. Once station management confirms that a vehicle meets the waiver criteria, an appointment with a Diagnostic Technician will be scheduled. The Diagnostic Technician must verify the repairs before a waiver can be approved.

WHAT IS VERI?

This document is a resource for customers who are choosing a repair facility to perform repairs on a vehicle that has failed the emissions test.

FINDING A REPAIR FACILITY

The repair facilities listed in this brochure are Indiana Certified Emission Repair Facilities. To receive this certification, these facilities employ at least one technician who has undergone extensive training in the diagnosis and repair of emission failures.

These facilities also have specific equipment and tools that are necessary to properly diagnose emissions failures.

Only repairs performed by facilities listed in this document will provide credit toward a waiver for a failing vehicle that is newer than model year 1981.

HOW TO USE THE VEHICLE EMISSION REPAIR INDEX

The Vehicle Emission Repair Index shows how successful Indiana Certified Emission Repair Facilities are when repairing vehicles that have failed their emissions test. In addition to listing the location, contact information and whether or not the facility works on imports as well as domestic vehicles, this document also includes the number of failing vehicles this facility has repaired in the past 12 months and the number of those vehicles that passed after repairs. The shops with the most success at repairing emissions failures will have numbers that are close to each other.
